Annual Percentage Yield (APY) Defined

APY is the total amount of interest that would be received on a deposit, based on the annual rate of simple interest and the frequency of compounding for a 365-day period, expressed as a percentage. If compounding of interest occurs during the term of a certificate of deposit, the APY assumes accrued interest remains in the account, and is not withdrawn until maturity of the certificate of deposit. Withdrawal of accrued interest during the term of a certificate of deposit will reduce the stated APY. Any withdrawal of principal made prior to maturity is subject to a penalty. The interest rate and APY may change on all variable rate accounts which include checking, insured money market and savings. Imposition of a fee can reduce the APY.
